BACKGROUND

The local short-term expert in the field of ICT in Component 3 (prevention of corruption) will work as part of the implementation team for the European Union grant-funded project “EU Support for Rule of Law” in North Macedonia. The project is being implemented by an experienced international partnership led by the Agency for European Integration and Economic Development GmbH and three Co-Applicants - the Ministry of Justice and Administration of the Republic of Croatia, the Ministry of Interior of the Republic of Austria and the Ludwig Boltzmann Institute of Fundamental and Human Rights.

The Overall Objective of the project is to strengthen the rule of law in North Macedonia. The project has four specific objectives: 1. To improve the capacities of justice institutions to deliver justice in transparent and accountable manner, 2. To strengthen the capacities to effectively implement modern investigation techniques in fighting organised crime, 3. To improve the prevention and fight against corruption, and 4. To enhance the protection of fundamental rights.

The local short-term expert in the field ICT in the area of anti-corruption (component 3) will support the State Commission for Prevention of Corruption (SCPC) and the Component Leader for Component 3.

ROLES AND RESPONSIBILITIES

- Develop proposed installation and start-up of the new servers in SCPC
- Migrate settings, applications and databases from old to new equipment
- Configure passive network equipment
- Support to the SCPC in ICT administration and management and training on regular system maintenance and daily operations
- Assist the SCPC in development of Terms of Reference for the SCPC and Component 3 for a tender to develop interconnectivity with databases and registers of various public institutions
- Assist the Component Leader for Component 3 in her tasks
